

CONGRATULATIONS on your recent purchase and we wish you many years of good use.

**Princecraft Boats Inc.**, ("Princecraft") provides the following limited warranty to the original retail purchaser of each 2008 boat trailer manufactured by REMEQ Inc. and distributed by Princecraft, if purchased from an authorized dealer in the United States and Canada, and operated under normal, noncommercial use ("Boat Trailer"), subject to the excluded items contained in the "This Limited Warranty Does Not Cover" section set forth below and other limitations set out in this Limited Warranty.

**Limited One-Year Parts and Components Warranty** 

The authorized dealer will repair or replace any defect in material or workmanship on the Boat Trailer which is reported within one (1) year of the date of delivery of the Boat Trailer to the original retail owner. This Parts and Components Limited Warranty does not apply to any items expressly covered or excluded by other sections of Princecraft's Express Limited Warranty.

**Limited Two-Year Paint/Rust Warranty** 

The authorized dealer will repair any peeling paint or rust on the Boat Trailer which is reported within two (2) years of the date of delivery of the Boat Trailer to the original retail owner.

Sole Remedy: THE REMEDY OF REPAIR OR REPLACEMENT OF PARTS THAT ARE FOUND TO BE DEFECTIVE IN FACTORY MATERIALS OR WORKMANSHIP COVERED BY THIS LIMITED WARRANTY SHALL CONSTITUTE THE OWNER'S SOLE AND EXCLUSIVE REMEDY AGAINST PRINCECRAFT FOR ANY CLAIMS WHATSOEVER OF ECONOMIC LOSS RESULTING FROM PRODUCT FAILURE. In no event shall any repair or replacement under this limited warranty exceed the fair market value of the owner's Boat Trailer as of the date the owner provides notification of the defect.

## OTHER LIMITATIONS

EXCEPT AS SET FORTH HEREIN, THERE ARE NO OTHER WARRANTIES EITHER EXPRESS OR IMPLIED PROVIDED BY PRINCECRAFT ON THIS BOAT TRAILER. ALL OTHER WARRANTIES, EXPRESS OR IMPLIED, INCLUDING IMPLIED WARRANTIES OF FITNESS AND MERCHANTABILITY, ARE EXPRESSLY EXCLUDED. PRINCECRAFT FURTHER DISCLAIMS ANY LIABILITY FOR ECONOMIC LOSS ARISING FROM CLAIMS OF PRODUCT FAILURE, NEGLIGENCE, DEFECTIVE DESIGN, MANUFACTURING DEFECT, FAILURE TO WARN AND/OR INSTRUCT AND ANY OTHER THEORY OF LIABILITY NOT EXPRESSLY COVERED UNDER THE TERMS OF THIS LIMITED WARRANTY.

TO THE EXTENT REQUIRED BY LAW ANY IMPLIED WARRANTY OF MERCHANTABILITY IS LIMITED FOR THE DURATION OF THE RESPECTIVE EXPRESS LIMITED WARRANTIES STATED HEREIN. TO THE EXTENT ALLOWED BY LAW NEITHER PRINCECRAFT, NOR THE SELLING DEALER SHALL HAVE ANY RESPONSIBILITY

FOR LOSS OF USE OF THE BOAT TRAILER, LOSS OF TIME, INCONVENIENCE, COMMERCIAL LOSS OR CONSEQUENTIAL DAMAGES. SOME STATES (OR JURISDICTIONS) DO NOT ALLOW LIMITATIONS ON HOW LONG ANY IMPLIED WARRANTY LASTS, SO THE ABOVE LIMITATION MAY NOT BE APPLICABLE. SOME STATES (OR JURISDICTIONS) DO NOT ALLOW THE EXCLUSION OR LIMITATION OF INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE LIMITATIONS OR EXCLUSIONS MAY NOT BE APPLICABLE. THIS WARRANTY GIVES THE OWNER SPECIFIC LEGAL RIGHTS, AND THE OWNER MAY ALSO HAVE OTHER RIGHTS WHICH VARY FROM STATE TO STATE (OR JURISDICTION).

**Statute of Limitations:** Any action for breach of express or implied warranty against Princecraft shall be barred unless it is commenced within one (1) year from the date of accrual of such cause of action.

## This Limited Warranty Does Not Cover:

- 1. Boat Trailers owned by parties other than the original retail owner.
- 2. Winch strap assembly, light bulbs, brake system, tire, wood bunk and load guide;
- Corrosion and damage to paint or galvanization due to road hazards:
- 4. Any failure or defect caused by accidents: theft; normal wear and tear; failure to provide reasonable and necessary maintenance; failure to comply with Princecraft's recommendations relating to use and care of the Boat Trailer; abusive/improper use; improper trailer set-up, or improper trailering;
- Damage due to improper repairs or modifications without authorization;
- 6. Any Boat Trailer for a boat used for Commercial Purposes (Commercial Purposes, as used herein, means a vessel with more than 50% usage for business or revenue-producing purposes);
- 7. Any failure or defect caused by alterations from factory specifications, including overloading in excess of published capacity rating:
- 8. Any Boat Trailer which has been salvaged or declared a total loss or a constructive total loss for any reason not covered by this limited warranty.

**No Transferability:** Princecraft's Boat Trailer limited warranty extends only to the first retail owner. This limited warranty does not transfer to any subsequent retail owner of the Princecraft Boat Trailer.

**No Waiver:** The terms and conditions contained herein, as well as those of any documents prepared in conjunction with the sale of this Boat Trailer may not be modified, altered or waived by any action, inaction, or representations, whether oral or in writing, except upon the expressed, written authority of a management level Princecraft employee.

## **Owner's Obligation**

Please submit the limited warranty registration card within 30 days of delivery of the Boat Trailer in order to activate warranty coverage. All warranty work or repairs must be referred to the authorized dealer for authorization as a condition precedent to limited warranty coverage. Princecraft must receive written notice of any remaining warranty claims from the owner prior to the expiration of the owner's limited warranty, and the owner must allow Princecraft an opportunity to resolve the matter.
