2013 EXPRESS LIMITED WARRANTY BOAT TRAILERS

WELCOME ABOARD THE PRINCECRAFT FAMILY

Princecraft Boats, Inc. ("Princecraft") provides the following limited warranty to the original retail purchaser of each 2013 model boat trailer manufactured by REMEQ, Inc. and distributed by Princecraft, if purchased from an authorized dealer in the United States and Canada and operated under normal, non-commercial use ("Boat Trailer"), subject to the remedies, exclusions and limitations set out in this Limited Warranty.

Limited One-Year Parts and Components Warranty

The authorized dealer will repair or replace any defect in material or workmanship on the Boat Trailer within one (1) year of the date of delivery of the Boat Trailer to the original retail owner. This Limited One-Year Parts and Components Warranty does not apply to any items expressly covered or excluded by other sections of Princecraft's Express Limited Warranty.

Limited Two-Year Paint/Rust Warranty

The authorized dealer will repair any peeling or rust on the original Boat Trailer within two (2) years of the date of delivery of the Boat Trailer to the original retail owner.

EXCLUSIONS

This Limited Warranty Does Not Cover:

- 1. Boat Trailers owned by parties other than the original retail owner;
2. Winch strap assembly, light bulbs, brake system, tire, wood bunk and load guide;
3. Corrosion and damage to paint or galvanization due to road hazards;
4. Any failure or defect caused by accidents: theft; normal wear and tear; failure to provide reasonable and necessary maintenance; failure to comply with Princecraft's recommendations relating to use and care of the Boat Trailer; abusive/improper use; improper trailer set up, or improper trailering;
5. Damage due to improper repairs or modifications without authorization;
6. Any trailer for a boat used for Commercial Purposes (Commercial Purposes, as used herein, includes but is not limited to any for-profit use);
7. Any trailer which has been salvaged or declared a total loss or a constructive total loss for any reason not covered by this limited warranty;
8. Any failure or defect caused by alterations from factory specifications, including overloading in excess of published capacity rating;
9. Any item exceeding the expressed coverage limits specified in any Princecraft Limited Warranty;
10. Any defect or repair requiring redesign of the Trailer, except pursuant to the recall laws of any jurisdiction.

SOLE REMEDY

THE REMEDY OF REPAIR OR REPLACEMENT OF PARTS OR MATERIALS THAT ARE FOUND TO BE DEFECTIVE IN FACTORY MATERIALS OR WORKMANSHIP COVERED BY THIS LIMITED WARRANTY SHALL CONSTITUTE THE OWNER'S SOLE AND EXCLUSIVE REMEDY AGAINST PRINCECRAFT FOR ANY CLAIMS WHATSOEVER OF ECONOMIC LOSS RESULTING FROM PRODUCT FAILURE. In keeping with environmental policies and practices, Princecraft reserves the right to utilize reconditioned, refurbished, repaired or remanufactured products or parts in the warranty repair or replacement process. Such products and parts will be comparable in function and performance to an original product or part and warranted for the remainder of the original warranty period. In no event shall any repair or replacement under this Limited Warranty exceed the fair market value of the product as of the date of the owner's claim. Acceptance of any product returned or any refund provided by Princecraft shall not be deemed an admission that the product is defective. Products that are replaced become the property of Princecraft.

OTHER LIMITATIONS

EXCEPT AS SET FORTH HEREIN, THERE ARE NO OTHER WARRANTIES EITHER EXPRESS OR IMPLIED PROVIDED BY PRINCECRAFT ON THIS BOAT TRAILER. ALL OTHER WARRANTIES, EXPRESS OR IMPLIED, INCLUDING IMPLIED WARRANTIES OF FITNESS AND MERCHANTABILITY, ARE EXPRESSLY EXCLUDED. PRINCECRAFT FURTHER DISCLAIMS ANY LIABILITY FOR ECONOMIC LOSS ARISING FROM CLAIMS OF PRODUCT FAILURE, NEGLIGENCE, DEFECTIVE DESIGN, MANUFACTURING DEFECT, FAILURE TO WARN AND/OR INSTRUCT AND ANY OTHER THEORY OF LIABILITY NOT EXPRESSLY COVERED UNDER THE TERMS OF THIS LIMITED WARRANTY.

ANY IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE IS DISCLAIMED. TO THE EXTENT THE IMPLIED WARRANTY CANNOT BE DISCLAIMED, IT IS LIMITED TO THE SHORTER OF ONE YEAR FROM THE DATE OF DELIVERY TO THE FIRST RETAIL OWNER OR THE DURATION OF THE RESPECTIVE EXPRESS LIMITED WARRANTIES STATED HEREIN. NEITHER PRINCECRAFT NOR THE AUTHORIZED DEALER SHALL HAVE ANY RESPONSIBILITY FOR LOSS OF USE OF THE TRAILER, LOSS OF TIME, INCONVENIENCE, COMMERCIAL LOSS OR CONSEQUENTIAL DAMAGES. SOME STATES (OR JURISDICTIONS) DO NOT ALLOW LIMITATIONS ON HOW LONG ANY IMPLIED WARRANTY LASTS, SO THE ABOVE LIMITATION MAY NOT BE APPLICABLE. SOME STATES (OR JURISDICTIONS) DO NOT ALLOW THE EXCLUSION OR LIMITATION OF INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE LIMITATIONS OR EXCLUSIONS MAY NOT BE APPLICABLE. THIS WARRANTY GIVES THE OWNER SPECIFIC LEGAL RIGHTS, AND THE OWNER MAY ALSO HAVE OTHER RIGHTS WHICH VARY FROM STATE TO STATE OR COUNTRY TO COUNTRY.

RETAIL CUSTOMERS IN THE EUROPEAN ECONOMIC AREA (EEA) MAY HAVE LEGAL RIGHTS UNDER APPLICABLE NATIONAL LEGISLATION REGARDING THE SALE OF RETAIL GOODS WHICH ARE NOT AFFECTED BY THIS LIMITED WARRANTY. THE RETAIL CUSTOMER'S LEGAL RIGHTS UNDER ANY APPLICABLE NATIONAL LEGISLATION REGARDING THE SALE OF RETAIL GOODS SHALL NOT BE AFFECTED.

STATUTE OF LIMITATIONS

Any action for breach of express or implied warranty against Princecraft shall be barred unless it is commenced within one (1) year from the date of accrual of such cause of action. This provision does not grant any consumer a right of rescission against Princecraft where such right does not otherwise exist under applicable law. Some states may not allow the applicable statute of limitations for rescission or revocation to be reduced, so this provision may not apply to each retail owner.

REGISTRATION & WARRANTY TRANSFER POLICY

Please submit the limited warranty registration card within 30 days of delivery of the Boat Trailer in order to activate warranty coverage. OWNER'S OBLIGATION

All warranty work or repairs must be referred to the authorized dealer for authorization as a condition precedent to limited warranty coverage. Princecraft must receive written notice of any remaining warranty claims from the owner prior to the expiration of the owner's limited warranty, and the owner must allow Princecraft an opportunity to resolve the matter. The invalidity or unenforceability of any one or more of the provisions herein shall not affect the validity and enforceability of the other provisions.
