Limited One-Year Parts and Components Warranty

The authorized dealer will repair or replace any defect in material or workmanship on the Boat Trailer within one (1) year of the date of delivery of the Boat Trailer to the original retail owner. This Limited One-Year Parts and Components Warranty does not apply to any items expressly covered or excluded by other sections of Princecraft's Express Limited Warranty.

Limited Two-Year Paint/Rust Warranty

The authorized dealer will repair any peeling or rust on the original Boat Trailer within two (2) years of the date of delivery of the Boat Trailer to the original retail owner.

EXCLUSIONS

This Limited Warranty Does Not Cover:

- 1. Boat Trailers owned by parties other than the original retail owner;
- 2. Winch strap assembly, light bulbs, brake system, tire, wood bunk and load guide;
